DESCRIPTION

Bleach detergent for cleaning and disinfection of floors, walls, sinks, kitchens It can also be used to disinfect clothes. Not suitable for the disinfection of drinking water. Professional use and by the general public.

FORM OF USE

APLICATION	HOW TO USE	
Walls and surfaces	Use pure, leave for a few minutes and rinse.	
Floors	Dilute 100 ml in 5 liters of water.	
Washing machine	Pour 100 ml into the bleach bucket. If the washing machine does not have a bleach box, dilute 100 ml of product in water and add in the second rinse (20 min before the end of the program).	
Soak / Hand wash	Dilute 100 ml in 10 liters of water. Add the clothes, leave for 20 min and rinse. Not suitable for washing colored clothes.	

Do not use on surfaces susceptible to being attacked by hypochlorite (aluminum, wood, textiles, crystallized surfaces, etc.).

Incompatibilities: In contact with acids, chlorine (very toxic gas) is produced. Other materials to avoid: compounds that contain nitrogen such as ammonia, urea, amines and the like, metals such as iron, copper, nickel and cobalt, as well as their alloys and salts.

In order to avoid risks to people and the environment, follow the instructions for use.
